I am going to pass on some figures regarding the status of our Association finances and what the Association is looking like in the future. We also have a maintenance account used to pay monthly expenses associated with mowing, upkeep and replacing some tombstones which have eroded, damaged or in some cases repaired or replaced. This account balance as of 30 November 2016 is \$37,098.67. As you can see we look pretty good on paper. Keep in mind the CD's maturity dates and if these are cashed in before maturity the interest would be forfeited. Also CD 8157 is the permanent fund account which according to the by-laws and constitution, the trustees cannot invade the principal for any reason other than discontinuance of the association.

Whites Chapel Cemetery is a non-perpetual care cemetery, family owned and the upkeep done by surviving family members. This means no trust fund for maintenance of your family member's burial space was established at the time of their death. In recent years persons who were buried in the cemetery paid \$200.00 for handling your family's arrangements and was deposited in the permanent fund. Interest is then rolled into the general fund for use in maintaining the cemetery. Whenever this fund was established interest was high enough to cover the expenses of maintaining the cemetery. Unfortunately todays rates are low, providing us with little interest per year.

The 2016 budget was \$8,383.00 for maintenance expenses. This year we spent \$8,841.09. Our contributions from members in 2016 was \$2294.09. Our expenses exceeded our intake by around \$5800.00 which was taken out of our maintenance account. Fortunately we did have the funds available but unfortunately without contributions coming in from our membership we are going to eat up our available funds. Therefore it is the task of the Treasurer to ask the family members to support the cemetery with contributions to our maintenance funds. You can make a tax exempt donation at any time during the year or a monthly contribution if this fits your situation better.
